- The 2012 RGA-QE is written on 14, 15 and 16 November 2012.
- Please note all candidates have to have successfully completed the Government Auditing Specialism Programme in order to be eligible to write the RGA-QE.

- Applications have to reach the Secretariat on or before the closing date: 30 September 2012 for candidates who do *not* participate in this year's GASP.

- 2 A copy of the candidate's GASP certificate issued by SAIGA (not applicable to this year's GASP 2012 candidates).
- 3 If the period of practical work is completed, proof thereof (certified record of the candidate's practical experience – specimen form provided on the website).
- 4 Proof of payment: Administration fee: R1,767 (R1,550+14%VAT) The administration fee is non-refundable in the case of unsuccessful applications.
- 5 Proof of payment: Examination fees for the papers to be written: Paper 1 – R9,690 (R8,500+14%VAT); Paper 2 – R10,260 (R9,000+14%VAT) and Paper 3 – R10,431 (R9,150+14%VAT).
Total amount for administration fee & three papers = R32,148 (R28,200+14%VAT).
